Sky Ranch has seen tremendous growth in the number of campers over the past 7 years. Summer campers have increased over 300% since 2010. To accommodate this growth, we are slowly upgrading our facilities. Sky Ranch was able to celebrate a milestone in the life of its ministry in 2015 with the completion of the new shower house. But congestion and overcrowding are pressing challenges as we continue to attract more campers and retreat groups to the ministry of Sky Ranch.

This year Sky Ranch has received an incredible gift and a remarkable pledge!

Sky Ranch received \$300,000 towards the construction of a new summer staff and retreat facility from an anonymous donor. As plans progressed, the donor gifted an additional \$130,000 towards this

project: a total of \$430,000. We also received a pledge from longtime supporter and past board president,

Kent Garvin. He has promised to build a 3,000 square foot maintenance structure. These wonderful gifts present us with an incredible opportunity to move our ministry forward, building facilities that support and enhance our growing camper and retreat ministries.

Both projects are in the design stage while we work with a contractor to finalize site preparation, utility, and infrastructure access, as well as permitting and approval. Construction will begin during the 2018 camping season and be completed during the fall

retreat season.

We are deeply grateful to our anonymous donor and to Kent Garvin for their generosity and faithfulness. We are very appreciative of their gifts and their confidence in this ministry to be an

extension of the church in the Rocky Mountain Synod and beyond. Thank you!

#### **BRAD ABBOTT—EXECUTIVE DIRECTOR**

2017 was an amazing year of ministry at Sky Ranch. Because of the support and generosity of many people, Sky Ranch served over 2,100 campers and adults through our summer ministry and another 1,000 in our spring and fall retreat ministry. Strong summer camper numbers and increasing retreat participants have dictated changes in program and facilities at Sky Ranch over the past year. These changes rise from a need to better serve God's people and God's church.

During 2017, the 500<sup>th</sup> celebration of the Reformation, it was fitting that we understood the role of change in our church and the ministry of Sky Ranch. The spirit of the reformation – the freedom to practice a relevant faith – continues to guide the board and staff of as we wrestle with how to best serve a growing and changing camper population. Here are a few highlights:

**Program** - We welcomed new Program Directors - Hannah Anderson and Jeff Fairfax— who implemented a new 'block schedule' allowing for more small group programming. Program Coordinators for each specific age group specialized in creating ageappropriate programming.

Facility - Staff and volunteers were busy installing new water lines for Christ Lodge and the campground, heat in the lower bedrooms of Christ Lodge, and building new benches for the Backpack Center & camper cabins. We continued to tackle deferred maintenance issues around the site.

**Policy** - The Board is updating Sky Ranch's governing documents and policy manual to adhere to best practices in outdoor ministry. Staff has updated procedures to meet ever changing regulations and realities.

**Financially** – Again, our operating budget finished in the black and we continue to reduce debt. This year we received an additional \$430,000 gift from an anonymous donor for the

construction of a new summer staff/retreat cabin in 2018. We also received a pledge from Kent Garvin to build a new 3,000 square foot facilities shop and storage garage at Sky Ranch in 2018!

As we adapt and change, it is vital to remember our commitment to our creed, community, people, and programs.

I am thankful for our summer staff and the ministry they do. Like the generations of staff that came before them they change young campers' lives by being authentic, and affirming. I am also thankful for Sky Ranch's full-time staff and board, who give selflessly of their time, talents, and energy throughout the year. It is a privilege to serve alongside them in ministry.

The mandate of the gospel is one of rebirth, restoration, and renewal. As we continue to minister to a changing culture, we also endeavor to honor our past. In 2018 Sky Ranch will celebrate its 55<sup>th</sup> anniversary. It is a wonderful reminder of the cloud of witnesses that make up this mountain ministry – past, present, and future.

#### HANNAH ANDERSON—PROGRAM DIRECTOR

This year on our staff backpacking training trip, we took the Surprise Pond trail from Comanche Reservoir to Twin Lakes. There are two surprises that give this trail its name. First, the trail is significantly longer than it appears. It isn't well labeled on a map and you spend most of the hike in a burn area, exposed to the weather. Second, sometimes Surprise Pond dries up and there is no longer a pond. The one reprieve of water only exists sometimes, and it is hard to predict when the pond will be full.

Surprise Pond sums up camp for me. Sometimes, we experience disappointment. The Pond is empty or the food truck is late or it rains for an entire week without stopping. We experience

challenges. A camper is homesick or a new maintenance issue arises. And yet, most of the time we find ourselves surprised by the joy and abundance we experience at Sky Ranch.

This year, we were overflowing with this abundance and joy. Our Surprise Pond was filled to the brim! We had an incredible group of summer staff from around the country. They were gracious and compassionate leaders who brought creativity and energy to everything they did. We had successful Four Winds trips in Denver, Fort Morgan, Harvest Farm, and up at camp—where youth were empowered to serve others and work for justice in their own communities. Our backpackers hiked a combined 4,775 miles this summer!

The ministry we are called to do is not straightforward or simple. Instead it is filled with change, transition, and complexity. As 2018 begins, we are in a place of great opportunity. We have the resources to invest in our property and facilities in big ways. Our campers and staff are eager to return year after year. We continue to be in a place where we change and grow out of opportunity—not out of crisis.

Our ministry is full of surprise—and we want you to walk alongside us in this journey. Each individual is vital to our community: the campers, staff, volunteers, and retreat guests. Your dedication and commitment in the midst of surprise and change give continued life to this place!

#### **IEFF FAIRFAX—PROGRAM DIRECTOR**

"For you shall go out in joy, and be led back in peace; the mountains and the hills before you shall burst into song, and all the trees of the field shall clap their hands." Isaiah 55:12.

Everyone who spent a week at camp this past summer heard this verse sung by staff at closing worship. As campers journeyed down the mountain and adapted to life without the seclusion of camp we hope they remember the joy of their time at camp. Over 2,000 guests got to experience the joy of camp this past year, whether it was participating in an onsite program, traveling day camp, high wilderness backpacking, service learning program, or as a retreat group. Each of these programs allows the Holy Spirit to be present, active, and relevant for campers and adults during their time at Sky Ranch.

For camp to stay relevant and adapt to the needs of those encountering Christ on the mountaintops, change is always necessary. Change happens within our logistics and curriculum, with the needs of congregations and communities, and within our staff.

This summer we implemented notable change in our onsite schedule. We moved to a model that allows campers

and their counselors to choose activities based on their preferences. We used three two-hour blocks each day: one for bible study, one for family groups, and the last for structured free time in the recreation area. The new schedule was welcomed by adults and campers alike.

We have also experienced change through an increase in requests for intergenerational ministry opportunities in congregations. Pastor Wendy Kalan and Shepherd of the Valley in LaSalle, Colorado hosted staff from Sky Ranch to lead an overnight campout for all ages at the church. The purpose of these events are twofold: to give the congregation a Sky Ranch experience, and to bring all generations together for fun, fellowship, and faith formation. In addition to this event, we have been in conversation with several congregations about the possibility of evening, all-ages, traveling day camps. We look forward to facilitating new and creative endeavors in partnership with congregations.

One of the biggest changes we see each year is within our summer staff, the 45-50 individuals who commit to Facilitating an Encounter with Christ each summer. It is exciting to watch these passionate individuals transform



over the course of the summer. Young adults who may appear quiet and reserved in their staff interviews quickly blossom into counselors who are faithful, full of joy, and welcoming. Relationships are formed among staff and campers that are remembered for life.

In life and ministry, change is inevitable. How we as a ministry react to, employ, and invoke change is the future. We welcome change as an opportunity to help campers experience camp in a new way, assist congregations as they adapt to changing landscapes, and walk alongside our staff as they transform and build relationships.

#### **PROPERTY UPDATE**

Season after season of encountering Christ leads to changed lives, but can also lead to wear and tear on property and facilities. We have been blessed by congregations, individuals, and campers who have invested time in caring for and improving Sky Ranch's property. Here are some of the highlights:

- In the last year we've saved nearly 700 gallons of water per day through new water lines, stand pipes, and an energy-efficient dishwasher.
- The basement lodge rooms now feature heaters and new electrical infrastructure, thanks to Randy and Tracy Pfeiff of R&T Electric.
- Memorial Day Work Weekend

- included bench building—led by Al Hemmah, which was completed by Bethany Lutheran Church's "Be the Blessing" weekend.
- The chuckwagon picnic area has been reconfigured and revitalized to accommodate more guests. Volunteers Duane Anderson and Bob McCarthy helped install a new awning and stairs to access the loading dock at the kitchen.
- Across the site we've worked for continued fire mitigation, nature trail improvements, and a fresh coat of paint on the Nurse's cabin, with the help of our Rendezvous campers.
- The Backpack Center chimney was

- refurbished and new laminate flooring in the packout area was installed by a group from Lord of the Valley Lutheran Church in Granby.
- Tom Bennett maintenance shed has a new metal roof, installed by David Fluck.
- Our fall hosts finished the new cross installation at the Outdoor Chapel.




The new summer staff/seasonal retreat cabin will have 4 bedrooms with individual bathrooms housing up to 32 people, a meeting area that will accommodate 50 people, and two external bathrooms for adjacent staff cabins to use. This winterized cabin will be located on the western edge of the property, behind Tubman cabin, allowing us to house all summer staff in one area. Relocating staff will open two more cabins for camper use and a third cabin for adult sponsor use. During the non-summer months, retreat groups will be able to rent this space. The cabin will require running new water lines and building a new septic & leach field for the western side of the property.



Kent Garvin is designing plans to construct a 3000 sq. ft. pole building with metal roof and siding that includes a 435 sq. ft. addition for living quarters. The 'Garvin Garage' will include a canopy shelter over a concrete slab suitable for outdoor storage or workspace. The building will be located on the eastern edge of the property, south of the summer staff parking lot. This is the fulfillment of a lifelong dream for both Kent and Sky Ranch. The elimination of the current maintenance building will allow us space in the center of camp to eventually build a covered pavilion.

# **Summer Camper Numbers**



Overall participation at Sky Ranch continues to grow! Our most significant growth continues to occur in retreat groups. We are generally operating at or near capacity for most weeks of camp!

Participation in 2015 dropped because of the ELCA Youth Gathering. A similar change is expected for the 2018 season as well.

Of the 948 residential program participants, 401 were Elementary or Junior High Students, 469 were High Schoolers, and 78 were adults.

 We are booked for two full busses for the trip to the ELCA Youth Gathering. As a congregation/youth leader who relies heavily on this ministry for my congregation's transportation to the Gathering, I am both excited and thankful for the many and various ways Sky Ranch makes my job easier – and more fun!



#### FRIENDS OF THE MOUNTAIN— GIFTS IN 2017

Camper fees (\$400 in 2017) cover only a portion of what it actually cost to go to camp. How can we do this? Two words: We Can't. Not without your help! Our "Friends of the Mountain" giving club helps to subsidize every camper to the tune of over \$145,000 each year! "Friends of the Mountain" is the organization of people who give leadership support to the Annual Fund through their gifts of \$100 or more during the course of a year. 
