# From the Executive Director

I love Camp! Why, you ask? It's fun, it's exciting, it's alive, it's exhaustive, and it's genuine. Genuine faith! At camp we live life differently, focusing on others instead of our own wants and desires. Who wouldn't love it? Since 2010, Sky Ranch has tripled the number of campers served in our summer ministry program. At a time when young people are quickly disappearing from the pews in our congregations or have left altogether; we have the gift of their presence in abundance at camp.

**2019** was an amazing year for Sky Ranch. As you read through this report, you will see how God works through this ministry to impact the lives of thousands of people each year. Here are a few highlights:

Facility – Thanks to the generous support of an anonymous couple, Sky Ranch dedicated the new Ruth cabin on May 11! The \$700,000+ summer staff/ seasonal retreat cabin has 4 bedrooms with bathrooms, capable of housing 32 summer staff with a meeting area and two external bathrooms. This winterized cabin is located on the western edge of the property and allows us to locate all summer staff in one area. Relocating staff provides three more cabins in the center of camp for camper use.

Financially – Your financial support allowed Sky Ranch to again finish in the black. Additionally, two designated gifts allowed Sky Ranch to create a new \$100,000 General Endowment Fund with the ELCA Foundation. We also continue to reduce our loan. Sky Ranch has reduced its liabilities by over \$600,000 during the past six years!

**Policy** – After much work, the Board has submitted the revised Sky Ranch Policy Manual to the Employers Council for legal and HR review.

#### Many facilities and infrastructure at Sky Ranch need to be renovated or replaced.

Some structures at Sky Ranch predate the ministry. These historic structures need to be preserved or renovated. Some buildings constructed after the ministry began are no longer adequate to serve as they were intended. While much work has been done in the past few years to improve infrastructure at Sky Ranch, there is still much to do to adequately serve our current and future populations.

- The shop area needs to be replaced.
- Christ Lodge is too small to serve all the needs for which it was designed.
- The historic Backpack Center and Tom Bennett cabin, though adequate for storage, need basic improvements in order to protect their character.
- Current well and water storage . needs to be addressed.

# From the Youth & Outreach Program Director

As I reflect on the past year of ministry at Sky Ranch I keep coming back to our theme and verse from this summer. In May we welcome environmental education groups to camp as well as the first of our summer staff began to arrive the week be-



fore Memorial Day. May included the kickoff of two and a half weeks of staff training, our annual Memorial Day work weekend, more snow, and the first rebuild of our platform tents.

June, July, and August were full of life and excitement at camp. I love hearing staff guide campers and adult sponsors during first word as they yell good morning to God's beautiful mountains, trees, fellow campers, and so much more. The moose of Sky Ranch were kind enough to share their home with us again, albeit a bit more curious and at times very nosy as they try to eat sack lunches from kids' backpacks. The summer also included the rebuilding of the platform tents two additional times, the snow just kept coming for us. During family camp a fire was reported 1.5 miles east of Sky Ranch. The first 24 hours were filled with questions until crews were able to

get to the fire. Our summer flew by and we had to say goodbye to our staff as we looked to the fall retreat season. Fall included additional environmental education groups, a confirmation retreat, numerous outside rental groups, a yoga retreat, and finally our annual Advent Retreat.

We were blessed this year with the continued love and support from our Sky Ranch Family near and far. Through your love and support of Sky Ranch we were able to live out our calling to Facilitate an Encounter and to be the light of Christ to those around us. We eagerly await another wonderful year of ministry in 2020!


